Ecovillage Training Center: In conjunction with the United Nations Institute for Training and Research (UNITAR), Global Ecovillage Network and Gaia University, the Institute educates international students and transfers technologies through an immersion pedagogy of ecovillage living, classroom activity and hands-on skill-building exercises, together with workshops, lectures, practical demonstrations, publications, and outreach on six continents. In 2011 GVI provided 18 public lectures and 8 extended workshops, and produced numerous publications, including Green Living Journal and The Biochar Solution, and course workbooks in several languages.

Ecovillage Network: GVI is building grassroots movements for ecologically responsible human community having social, economic & ecological sustainability. In 2011 this program included tree-planting in Senegal with the Global Environmental Facility, workshops on financial permaculture in China, Jordan, Spain, Estonia and elsewhere, and participation (with consultative status) at the United Nations Framework Convention on Climate Change in Durban, S.A. Global Village Institute is the parent organization for the Ecovillage Network of the Americas and has been a regional office for the Global Ecovillage Network.

Culture Change: The only realistic response to the "hyperwicked" problems of climate change, peak oil, population explosion and the converging limits to growth is not scientific or technological but cultural. Culture Change is GVI's partnership to chart a new course to the era after petroleum; a car-free, air travel-restricted world of renewable energy, sail and rail. Among the projects GVI sponsors are the Sail Transport Network and the effort to reduce the use and disposal of petroleum-based plastics. Two internet-based journals, Culture Change and The Great Change, are published.

Grants and other forms of assistance are made to qualifying organizations approved by the Institute's staff and directors. It is the nature of the kind of trainings we perform that the number of actual recipients of the trainings is small. We train trainers.

In a given year we may instruct 20 or fewer trainers in each project. The number of people reached by these graduates and their work products is quite large, however. It is expected to exceed several thousand people per project, per year. In the case of the Mexican project in 2011, we likely reached more than 80,000 people whose lives were enhanced in matters regarding health, food security, and self-empowerment.
