ARTICLE I

MEETINGS OF MEMBERS

1. Annual Meetings. The annual meeting of the members shall be held during the month of November at such time and place, either within or without this State, as may be designated from time to time by the directors.

2. Special Meetings. Special meetings of the members may be called by the President, any director or any two members. The place of said meeting shall be designated by the directors.

3. Notice of Members' Meetings. Written or printed notice stating the place, day, and hour of the meeting, and, in the case of a special meeting, the purpose or purposes for which the meeting is called and the person or persons calling the meeting, shall be delivered either personally or by mail by or at the direction of the President, Secretary, Treasurer, officer, or person calling the meeting to each member entitled to vote at the meeting. If mailed, such notice shall be delivered not less than ten (10) nor more than sixty (60) days before the date of the meeting, and shall be deemed to be delivered when deposited in the United States mail addressed to the member at this address, with postage thereon prepaid. If delivered personally, such notice shall be delivered not less than five (5) nor more than sixty (60) days before the date of the meeting, and shall be deemed delivered when actually received by the member. The person giving such notice shall certify that the notice required by this paragraph has been given.

4. Quorum Requirements. A majority of the members entitled to vote shall constitute a quorum for the transaction of business. A meeting may be adjourned despite the absence of a quorum, and notice of an adjourned meeting need not be given if the time and place to which the meeting is adjourned are announced at the meeting at which the adjournment is taken. When a quorum is present at any meeting, a majority in interest of the members there shall decide

any questions brought before such meeting, unless the question is on upon which, by express provision of this corporation's Charter, these Bylaws, or by the laws of the State of Tennessee, a larger or difference vote is required, in which case such express provision shall govern the decision of such question.

5. Voting and Proxies. Every member entitled to vote at a meeting may do so either in person or by written proxy, which proxy shall be filed with the Secretary before being voted. Such proxy shall entitle the holder thereof to vote at any adjournment of such meeting, but shall not be valid after the final adjournment thereof. No proxy shall be valid after the expiration of eleven (11) months from the date of its execution unless otherwise provided in the proxy.

6. Members. All persons residing within the city of Lebanon and Wilson County, Tennessee, are eligible to become members of the corporation upon application, payment of the one-time initial joining fee, and maintaining monthly dues as long as they remain residents. All members 18 years of age and older shall have voting rights. A member shall become inactive when it is determined that he or she is over three months in arrears in payment of dues and shall no longer have voting rights.

ARTICLE II

BOARD OF DIRECTORS

1. Qualification and Election. Directors need not be members or residents of this state, but must be of legal age. They shall be elected by a plurality of the votes cast at the annual meeting of the members. Each director shall hold office until the expiration of the term for which he is elected, and thereafter until his successor has been elected and qualified.

2. Number. The number of directors shall be fixed from time to time by the members, or by a majority of the entire Board of Directors, but shall never be less than the number required by law.

3. Meetings. The annual meeting of the Board of Directors shall be held immediately after the adjournment of the annual meeting of the members. The Board may also designate more frequent intervals for regular meetings. Special meetings may be called at any time by the President or any Director

4. Notice of Directors' Meetings. The annual and all regular board meetings may be held without notice. Special meetings shall be held upon notice sent by any usual means of communication not less than three (3) days before the meeting.

5. Quorum and Vote. The presence of a majority of the Directors shall constitute a quorum for the transaction of business. A meeting may be adjourned despite the absence of a quorum, and notice of an adjourned meeting need not be given if the time and place to which the meeting is adjourned are fixed at the meeting at which the adjournment is taken, and if the period of adjournment does not exceed thirty (30) days in any one adjournment. The vote of a majority of the directors present at a meeting at which a quorum is present shall be the act of the Board, unless the vote of a greater number is required by the Charter, these Bylaws, or by the laws of Tennessee.

6. Executive and Other Committees. The Board of Directors, by a resolution adopted by a majority of its members, may designate an executive committee, consisting of two or more directors, and other committees, consisting of two or more persons, who may or may not be directors, and may delegate to such committee or committees any and all such authority as it deems desirable, including the right to delegate to an executive committee the power to exercise all the authority of the Board of Directors in the management of the affairs and property of the corporation.

ARTICLE III

OFFICERS

1. Number. The corporation shall have a President, a Secretary, and a Treasurer, and such other officers as the Board of Directors

shall from time to time deem necessary. Any two or more offices may be held by the same person, except the offices of President and Secretary or President and Treasurer.

2. Election and Term. The officers shall be elected by the members at the annual meeting. Each officer shall serve until the expiration of the term for which he is elected, and thereafter until his successor has been elected and qualified.

3. Duties. All officers shall have such authority and perform such duties in the management of the corporation as are normally incident to their offices and as the Board of Directors may from time to time provide.

ARTICLE IV

RESIGNATIONS, REMOVALS AND VACANCIES

1. Resignations. Any officer or director may resign at any time by giving written notice to the President or the Secretary. Any such resignation shall take effect at the time specified therein, or, if no such time is specified, then upon its acceptance by the Board of Directors.

2. Removal of Officers. Any officer or agent may be removed by the Board whenever in its judgment the best interests of the corporation will be served thereby.

3. Removal of Directors. Any or all of the directors may be removed either with or without cause by a proper vote of the members; and may be removed with cause by a majority vote of the entire Board.

4. Vacancies. Newly created directorships resulting from an increase in the number of directors, and vacancies occurring in any office or directorship for any reason, including removal of any officer or director, may be filled by the vote of a majority of the directors then in office, even if less than a quorum exists.

ARTICLE V

MEMBERSHIP CERTIFICATES

1. Membership Certificates. Every member shall be entitled to a certificate showing membership in the corporation in such form as may be prescribed by the Board of Directors. Unless otherwise decided by the Board, such certificates shall be signed by the President and the Secretary of the corporation. Such certificates shall not be transferable.

2. Loss of Certificates. In the case of the loss, mutilation, or destruction of a membership certificate, a duplicate certificate may be issued.

ARTICLE VI

ACTION BY CONSENT

Whenever the members or directors are required or permitted to take any action by vote, such action may be taken without a meeting on written consent, setting forth the action so taken, signed by all the persons or entities entitled to vote thereon.

ARTICLE VII

1. To provide the opportunity for affordable and desirable housing for all low to moderate income residents of Lebanon and Wilson County.

2. To foster a collaboration between local government, neighborhood organizations, business and civic leaders and other individuals, agencies and organizations interested in expanding housing opportunities for low to moderate income households.

3. To combat the local problems of substandard housing conditions through rehabilitation of existing substandard housing units.

4. To develop new housing facilities in the place of blighted structures or blighted vacant sites in existing inner-city areas for the purpose of combatting the deterioration of the community and contributing to its physical improvement.

5. To promote the application of design standards that will enable housing developments and units to meet the special needs of diverse segments of the low and moderate income housing market.

6. At least one-third (1/3) of the Directors shall be either:

- (1) Low income residents of the City of Lebanon or Wilson County; or
- (2) Residents of low income neighborhoods within the City of Lebanon or Wilson County; or
- (3) Elected representatives of low income neighborhood organizations within the City of Lebanon or Wilson County.

Not more than one-third (1/3) of the Directors shall be representatives of the public sector.

ARTICLE VIII AMENDMENT OF BYLAWS

These bylaws may be amended, added to, or repealed either by:

(1) a majority vote of the members represented at any duly constituted membership meeting, or (2) a majority vote of the entire Board of Directors. Any change in the bylaws made by the Board of Directors, however, may be amended or repealed by the members.

CERTIFICATION

We certify that these bylaws were duly adopted at the organizational meeting of the corporation held on the 7 day of Aug 7, 1995, and were approved by all the members on that date.
