PRIMARY ACTIVITIES INCLUDE TEACHING, DEVELOPMENT AND IMPLEMENTATION OF A CHRISTIAN K-12 CURRICULUM USED TO SERVE APPROXIMATELY 2400 STUDENTS ENROLLED IN THREE SCHOOLS KNOWN AS THE SCHOOL OF THE MEDES.
