Maternal help is provided in the form of diapers, formula, baby clothes, and baby furniture. Services provided include pregnancy testing, ultrasound, and post abortion counseling. One thousand, four hundred and three clients were served in 2011. The Center also taught Project Truth adolescent whole health education to more than 6,000 students in three counties.
