Our special Hurricane Account went dormant during early 2011, with the death of the previous president, and the subsequent death of the previous treasurer's husband, no one was seeing the statements. The bank was charging a \$10 per month service charge, and I reactivated the account which had accumulated \$100 in dormant fees.

With the down economy, our investments are primarily in guaranteed allocations, and not much in donations are coming through.

We hope that sailing as a community recreation does not wither any more than in the last couple of years.
