THE PROSPERITY CENTER OF GREATER JACKSON (Established in 2010) The Prosperity Center of Greater Jackson is an innovative "one stop-shop" facility offering a variety of the essential components needed to prepare an individual/family for growth and development as it relates to career exploration, financial management, legal services, capacity building, etc The Center was established through partnerships with United Way of the Capital Area, Midtown Partners, Mississippi Department of Human Services, and CredAbility The Center provides the following components * Economic Assistance (Temporary Assistance to Needy Families - TANF)* Work Ready & Job Placement Services* Life Skills* Budget and Credit Counseling* Preventive Financial Education* Housing Counseling* Legal Assistance* Supplemental Nutritional Assistance Program (SNAP)* Drug and Alcohol CounselingThe office services individuals that live in the following zip codes 39202, 39203, 39204, 39205, 39216 and served over 800 clients during 2011

LITTLE SAMARITAN MONTESSORI CENTER (Established in 2003) The early childhood center provides affordable childcare and education for children 0-5 based upon the Montesson principles founded by Maria Montessori The center consists of six classrooms, which includes two baby rooms, two one-year old rooms, one 2-year-old room and two 3-5 year old room for a combined full day enrollment of 83 In addition, Little Samantan is providing afterschool services to 17 children enrolled in the McWillie Montessori school program While enrollment opportunities are open for all families, preference is given for those living in the Midtown community

PROJECT INNOVATION (An Exploratory Learning After School Experience - Established in 2009) Project Innovation is a child-centered and community-based learning experience based on intellectual exploration The organization offers developmental and enrichment experiences for approximately 40 2nd - 5th grade children and youth and their parents in the Midtown (mid-Jackson) community who attend Brown Elementary School The afterschool program is founded upon the components involving STEM (Science, Technology, Engineering and Math) and includes activities relating to aviation, community gardening, arts, and technology and leadership development

MIDTOWN COMMUNITY KITCHEN (Established in 2000) The community kitchen provides free, nutritious meals for a variety of programs in the Midtown area Prepared lunches are delivered to * Homebound seniors and disabled living in the Midtown community (Meals with Wheels - currently 40 on route) * Individuals who are performing community service at various Midtown non-profit organizations (approximately 15) SENIOR CASE MANAGEMENT (Re-established in 2008) Case Management program focuses on social services and case management for homebound seniors and disabled individuals living in the Midtown neighborhood The program begins with delivery of a noon meal, and continues with routine home visits from a case manager The family advocate worker coordinates meal delivery and assesses the basic needs of the clients in the program Based on the assessment, referrals are made to partnering non-profits to secure assistance for the individuals with regards to food, clothing, medicine, transportation, etc During 2011, approximately 45 seniors/disabled were served MIDTOWN'S BIGGEST LOSER (Established in 2009) Encouraged by the popular "Biggest Loser", Midtown stakeholders designed their own health & wellness program focused on losing pounds by eating smarter, moving more, and developing healthy habits while supporting each other Prizes are awarded to the team and individuals losing the most pounds During the 2011 season, the following components were included in the curriculum healthy cooking, salsa dancing, and cardio workouts UNITY BOOK CLUB OF MIDTOWN (Established in 2007) Inspired by the residents' interest in becoming more involved in the Jackson Public Schools' summer reading requirements for their children, the "Unity Book Club" of Midtown was established Since the formation of the book club in 2007, the group has studied a number of readings to include not only those on the summer reading list but also authors focusing on leadership, motivation, self-awareness, etc To date, the club has read a total of 21 books - pieces of literature with six of those being read in 2011

The EARLY CHILDHOOD COMMISSION OF MID-JACKSON (Established in 2008 - Renamed in 2011) Mid-Jackson Family Resource Center Located at 329 Adelle Street, the family resource center provides assistance to families and early childhood centers located within the zip codes of 39202 and 39203 Assistance includes resources related to child development along with a wide range of materials that childcare workers can use to enhance the experiences of those children enrolled in their centers Materials include copying services, dye cuts, laminating machine, an overhead projector for project layouts and developed thematic units The resource center served over 1,000 visitors during 2011

BACKPACK BUDDIES (Established in 2010) Midtown Partners, Inc through the Project Innovation Afterschool program has partnered with Mississippi Food Network to become a site for their "Backpack Buddy" Food Program The Backpack Program was designed to meet the needs of hungry children at times when other resources are not available, such as weekends and during school vacations On each Friday, backpacks are filled with nutritious snacks and then sent home with students for a weekend supplement On Monday, the students return the backpacks to the program in preparation for restocking and distribution on the following Friday The "Backpack Buddy" program is currently serving 40 students UNACARE HEALTH CLINIC Midtown Partners provided rental assistance in the amount of \$18,000 for the community-based clinic entitled Unacare which is overseen by the University of Mississippi Medical Center - School of Nursing In 2011, the clinic served approximately 200 residents per month
