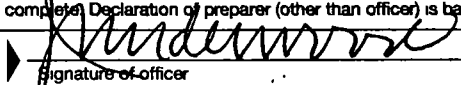

The sole purpose of The Hundred Club of Jackson is to support the Police and Fire Departments of the City of Jackson, Mississippi and the Sheriff's Department of Hinds County, Mississippi. The Club was founded in August 1961 and for 50 years has been the first responder from the community when an officer or fireman dies in the line of duty. The Club also provides support to the departments and related foundations on selected projects.

The highlight of the Club's year is its annual dinner to thank and recognize the public servants from the Police, Fire and Sheriff Departments. The highest awards of the various departments are announced and presented at the dinner, and The Hundred Club provides the winners with a plaque and a cash award.
