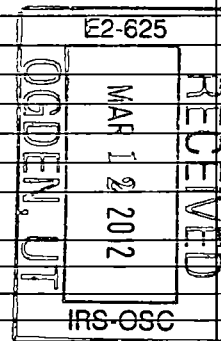

### **STUDENTS OF ABACO AND ELEUTHERA TO BENEFIT FROM PRIME TIME EDUCATIONAL FOUNDATION**

On Friday March 5, 1999 Bob and Judy Yanover of Jupiter Florida announced the establishment of the Prime Time Foundation to benefit one student of Abaco and one from Eleuthera annually in their pursuit of Tertiary Educational opportunities at three universities, namely University of Michigan, Louisiana State University and The University of Florida.

The Yanovers have been cruisers in The Bahamas since 1985 and have named the foundation after their vessel Prime Time. Their purpose is to provide College Scholarships to worthy students from The Bahamas, with special consideration given to the Abacos and Eleuthera.

Mr. Simpson McKinney, of Treasure Cay Abaco, will serve as the local coordinator in conjunction with the District Superintendent of Schools for Abaco Mr. Jackson McIntosh, and Mrs. Carretta Ferguson, Superintendent of schools for the Island of Eleuthera. Their role will be to develop a list of potential candidates which will be presented to the Foundation and the participating Universities for final selection. The awards will be based upon scholastic achievement, character of the individual and recommendations of their teachers. Candidates must successfully pass their S.A.T. and should have been accepted by one of the three schools prior to their application.

The scholarships will include all tuition and room and board. They will be for a period of one year, and will be extended for up to four years based upon the performance of the student.

It is the strong wish of the Foundation, that the successful graduates of this program return home for a minimum period of five(5) years so as to contribute their skills to the improvement of life in The Bahamas.

The scholarships come into affect during the Fall of 1999 and all applications should be returned to the office of the Superintendent of Schools on Abaco and Eleuthera on or before July 19, 1999. The Foundation has the right to reject any or all applications.
