28 Following Hurricane Irene, EWF deployed to the most devastated area of The Bahamas at the request of the Bahamian Government to conduct critical infrastructure surveys involving sewer, water, electricity, academics, transportation, medical and security - known as SWEAT-MS in the disaster field. Using EWF's revolutionary cell phone software, field responders collected data and images in a disconnected environment (no cellular, wireless, or internet service or electricity), enabling the Bahamian Government to quickly identify and address the unmet needs of hurricane survivors. EWF also delivered 40 pallets of donated building and cleaning supplies, tarps, Vita Meals and Meals Ready To Eat.

29 EWF deployed to Japan just three days after the catastrophic earthquake that devastated the region in March of 2011. EWF was able to perform a rapid operational risk assessment in the Sendai region of Japan while making contacts with numerous Japanese Non-Government Organizations (NGO). The team also set up an international distribution chain with an alliance of U.S.-based NGO's that funnels donations from the U.S. directly to impacted Japanese survivors via 213 Japanese churches and local NGO's.

30 During 2011, EWF responded to three natural disasters: Tornadoes in the United States, the Japan Earthquake and Tsunami and Hurricane Irene in The Bahamas. Following the outbreak of tornadoes and the flooding in 2011, EWF, already involved in its 4-state New Madrid, full-scale exercise, deployed and performed situational assessments in five states including Missouri, Arkansas, Kentucky, Tennessee, and Georgia. All information collected was time/date stamped and geocoded by the Pathfinder Rapid Assessment System (PRAS). This data was then synthesized into Executive Summaries which provided situational awareness regarding damaged residences and infrastructure that required immediate attention.
