Document all meetings and write a follow-up letter (send certified return receipt requested) or e-mail to the landowner confirming any agreements made on site about the restoration of the property and compliance dates. If the landowner agrees to restore the property. The site should be revisited on the deadline date, and the restoration work should be documented with photographs, narrative description, and quantitative measurements.
