In 2011, AVEH completed negotiations to replace its three mortgage loans from a commercial lender and the former owner with three new loans from community members This reduced interest rates and simplified loan terms The refinance also split the loans between AVEH's house and duplex parcels, thus giving it the flexibility to sell one parcel in case of financial necessity Because it has rented out the duplex and house, the refinancing means it now has a positive monthly cash flow, so that each dollar now raised can go toward a fund to build a five-unit assisted living facility, rather than servicing mortgage loans Along with this effort, it conducted several fundraising events throughout the year, the proceeds of which were added to its building fund At the end of the year, AVEH received a pledge of \$100,000, half of which was granted immediately, the other half to be provided once the full \$100,000 is matched by other donations
