

STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

Activities in 2011 focused on three themes – oral health literacy, access to care issues, and education/mentoring. In April, the Santa Fe Group convened a session at the National Oral Health Conference entitled “Connecting the Docs.” This program educated public health stakeholders about the importance of linking medical and dental delivery systems to improve patient care, particularly in identifying oral diseases in children under age 3. The Santa Fe Group partnered with Maryland State Oral Health Coalition in planning their 2011 oral health conference focused on improving access to dental care for underserved populations. In October, the Kellogg Foundation sought Santa Fe Group’s help in getting organized dentistry to engage in discussions regarding the dental therapist and other workforce models designed to improve access to oral health. The Santa Fe Group presented a proposal to Methodist Health Ministries in San Antonio after the organization sought SFG’s partnership in organizing a conference to engage state stakeholders to explore access to oral health care. This conference may convene in 2012. The group continues to develop the Meskin Fellows Program. Other activities involved assessing the Santa Fe Group brand, building brand awareness, and improving communications through print and electronic media.
