ANOTHER \$10,000 WAS CONTRIBUTED TO THE FOUNDATION BENEVOLENCE FUND TO AID EMPLOYEES OF THE WASHINGTON REGIONAL MEDICAL SYSTEM WHO HAD EXTREME FINANCIAL EMERGENCIES.
