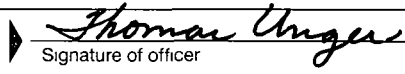

**Part V, Line 34**

The organization's bylaws were amended in December, 2011 as follows:

**Article VIII – Elections**

Amended to delete the requirement of boat ownership for a member to serve on the Board of Directors.

**Article XI – Dues and Fees**

Amended to provide for an increase in dues and fees should the member elect to pay monthly. If the member elects to pay annually by January 15 then the fees and dues remain the same as they are currently. For those members who repeatedly are delinquent in paying fees and dues, the amendment further provides that for those members who are delinquent by sixty (60) days twice in any consecutive twelve (12) month period, then they lose the option of paying on a monthly basis and can only pay dues on an annual basis commencing the first of the next calendar year.
