Environmental Education Programs - Outreach and Home Energy Audits: Conducted door-to-door outreach, signing residents up for free energy audits, recycling trees and resources. Completed home energy audits with minor implementation in 474 homes in Denver and Commerce City. Of these units, 73 received major upgrades such as insulation or energy efficient appliances through Groundwork Denver and 437 were assisted in completing the application for their County Weatherization Program. Additionally, 641 contacts were referred to partner an organization to complete audits in Denver. Completed outreach to engage households in 12 target neighborhoods, with funding from DEH CSG.

4b (Code:) (Expenses \$ 193,032. including grants of \$ 0.) (Revenue \$ 225,626.)

Green Team Youth Employment Program: GWD's year-round program employed 13 youth who worked in urban gardens and on neighborhood improvement and civic engagement projects related to environmental issues as well as healthy eating and active living. Provided rehabilitation, restoration and enhancement work in National Parks and at Rocky Mountain Arsenal, by engaging 12 additional young people in summer conservation jobs. Coordinated Colorado's Summer of Service, which consisted of service learning projects in three national parks involving youth crews from six different organizations.

Environmental Education Programs - Colorado Student Energy Awareness and Outreach Project: Finished second year of training program to increase awareness among students and adults of strategies to achieve energy efficiency and of the "green" career opportunities available in the energy efficiency and renewable energy industries in Colorado. Implementation in 2011 resulted in 581 Student Energy Ambassadors, 7,006 students trained and 15,183 adults trained. Contract continues through 2012.
