28 Organic Farming for Healthy Forests Organic farming techniques allow farmers to grow more food, more cheaply, on their existing land, while building up the soil. This is in direct opposition to "slash and burn" agriculture which calls for clearing and burning, increasing erosion and degradation of the land. Our four month training program was offered free and open to all comers. A major focus of this training is teaching farmers how to make and use compost to improve soil fertility, thus avoiding the need for expensive chemical fertilizers. Success is measured in increased food grown locally at less expense. Sea Turtle Conservation Program Continuing with our sea turtle awareness program in the schools and villages has increased concern for turtle protection. These animals and their eggs are fully protected under Indonesian law, but the law is rarely enforced. In the 2011 season, in addition to nightly patrols of nesting beach sites, villagers and ALTO tested two approaches: guarding the nesting area, or relocating eggs to a protected hatching site. After studying the results of these two techniques, it has been determined the relocated nests produced more hatchlings and will be the preferred method in the future. Other Projects Continue Our protection of maleo birds and eggs continues. Results are measured in increased bird density. ALTO is still working with villagers to protect the priceless and irreplaceable tropical forests of Mt Tompotika. With support of donors from around the world, we are protecting 25,000 acres of intact forest in several adjacent parts, as well as several additional patches of stream corridors and riparian forests. Awareness Program Grows The local reception of our awareness programs (maleo birds, turtles, trash management, native forests) has created the need for increased staff.
