Counseling, advice and instruction; financial, moral, public interest, etc. Broadcasting to approximately a 40 mile radius each on two stations, partly by volunteer workers. Public service announcement emergency alert systems and Amber Alerts are a part of our service to our communities. As results are intangible and number of listeners fluctuates, it is impossible to list how many problems are helped or resolved as a direct result of broadcasts. Listener response is very positive and indicates appreciation for the service provided. Many responses indicate personal improvement and problems resolved as a direct result of advice/counsel received from broadcasts. Appreciation for service provided is apparent since all operating costs are met by voluntary listener contributions-direct public support.
