over several years, was seen on many PBS stations.

• "Sons of Tennessee Williams," a documentary on gay civil rights history and issues, in New Orleans, went into theatrical distribution

• "Walker Percy: A Documentary," a documentary film about the writer Walker Percy, was seen on many PBS stations

• "Shell-Shocked: NOLA Youth" a documentary on the violence that some children in New Orleans encounter, was nearing completion

• A documentary produced in the 1980s called "Piano Players Rarely Ever Play Together," about several famous New Orleans piano players,

continued in distribution

• "Bayou Maharajah," a documentary on piano player James Booker, continued in production.
