WILDLIFE & BIODIVERSITY CONSERVATION EDUCATION & LEADERSHIP: The organization publishes educational materials, maintains a reference library, provides keynote speakers, produces films, publishes newsletters, attends key meetings and conferences world-wide, and issues alerts and press releases to educate the public on current wildlife conservation, habitat and biodiversity issues. 2011 conservation projects include the India Barasinga Project, the Mexican Desert Sheep Project; the Quest Ministries Projects (i.e., the annual Special Youth Challenge Hunt for special needs children and the annual Billy Ray Parnell Memorial Purple Heart Hunt); and Camp Force, a youth camp in Texas.

COMMUNAL BASED NATURAL RESOURCES MANAGEMENT (CBNRM): The major CBNRM projects are our partnership with the Conamar Foundation in Panama and the Robin Hurt Wildlife Foundation (RHWF) in Tanzania. We are a funding partner of the RHWF which has built 48 schools, operates 12 medical dispensaries, 2 mobile medical units, and 3 full time anti-poaching patrols fully equipped with vehicles, uniforms, etc. The project has been in continuous operation for 17 years and has grown both in scale and scope. We currently partner with 33 villages spanning 8 Districts and 7 Regions throughout Tanzania. Given the fact that 70% of all Tanzanians live at the resource base level, 40% of Tanzania's land area is covered by one form of Protected Area or another, and 30% of the total land area is covered by hunting blocks,

CONSERVATION EASEMENTS - LAND TRUST DIVISION: One of Conservation Force's primary purpose is the conservation of wild places, wildlife and our way of life. Thus, Conservation Force is a land trust. We are establishing conservation easements to maintain wild places for wildlife on private lands for their perpetual sustainable use in their natural condition. We also own and hold mitigation bank easements to restore and protect the natural, scenic or open space of land to ensure natural areas forever.
