The organization creates and connects partnerships between both traditional human/social service agencies and non-traditional supports and services to assist families in resolving a crisis.

Common Goods Charity Thrift Store: operated a thrift store to continue mission of supporting children and families. Utilized ~250 volunteers (1,870 vol. hours) to assist in store operations and processing donations. The goal of Common Goods is to have a major impact on the number of products leaving the area and/or entering landfills. Goods are recycled and redistributed within the community, and as a result, local donations stay local and proceeds from the store serve local families in need.

4b (Code:) (Expenses \$ **113,261** including grants of \$ **39,845**) (Revenue \$ **-0-**)
Resource Connection Services: assisted 2,081 households (~5,431 people) who were experiencing a financial crisis or short-term challenge or need, connecting them to viable community resources (both formal and informal programs and services), with the goal to improve family stability and wellbeing. Provided \$39,845 in assistance for 280 households when all existing resources had been exhausted.

Family Support Services: provided preventative short-term case management services for 135 at-risk households (486 people) with young children, connecting them to community-based family support services and empowering them to access future community supports independently, with the goal to prevent child abuse and reduce the number of families screened into county Child Protective Services. Provided \$7,684 in assistance for 31 households when all existing resources had been exhausted.

The change of \$16,479 was an adjustment for the current and previous years' bookkeeping error in the area of payroll liabilities; specifically, payroll taxes were being incorrectly recorded (twice). The correction was made and now correctly reflects the actual payroll liabilities (cf Part X, line 26).
