THIS IS THE EIGHTH YEAR CONTRIBUTIONS HAVE BEEN MADE TO THIS EFFORT, AND THE BOARD IS COMMITTED TO HELP FUND THIS CLINIC'S OPERATIONS ON AN ONGOING BASIS.

FINALLY, JCMH HEALTH CARE CORPORATION CONTINUES TO PROVIDE HEALTH CARE SERVICES THROUGH ITS SCANNER SERVICE AND ITS ASSISTED LIVING FACILITY. THESE ENTITIES CONTINUE TO PROVIDE NEEDED SERVICES TO THE RESIDENTS OF SOUTHWESTERN OKLAHOMA AND NORTH TEXAS.
