Total gross revenues from the medical office buildings were \$188,100 with related lease expenses of \$110,755 which is netted in the program revenue amount.

McCurtain Memorial Hospital Foundation participates and provides leadership in various community efforts of identifying and discussing the social and economic issues of the county and how they relate to healthcare. These efforts include participation in the McCurtain County Coalition for Change-Turning Point monthly meeting, development and leadership provision of the Domestic Violence Task Force and the McCurtain County Child Abuse Awareness Team. In an effort to improve community access to emergency medical services, the Foundation has also been heavily involved in the development of 911 and E-911 Task Forces which led the efforts toward a successful election to fund the E-911 service for all of McCurtain County. 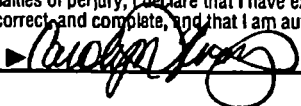
