Energy and Infrastructure - Responding to issues surrounding climate change, energy resources, and changing technologies, a bipartisan group of 20 of the nation's leading energy experts formed the national commission on energy policy (NCEP) in 2002 After more than two years of research and debate, NCEP released its long-term strategy for meeting America's energy challenges This consensus plan aimed to enhance American national security, strengthen the U S economy, and protect the global environment and public health In late 2010, Bipartisan Policy Center (BPC) ended NCEP and created a new effort, simply called the Energy Project, to more effectively and strategically contribute to the ongoing debate The project's goal is to encourage substantive, bipartisan dialogue among key interest groups and decision makers on national energy goals and strategies, engage and shape the near-term energy policy agenda, and develop consensus recommendations to guide national energy policy in the post-2012 elections The focus is on security and other critical issues, including domestic oil and natural gas production, U S nuclear power, energy subsidies, clean energy financing, technology innovation and power sector emissions and reliability
