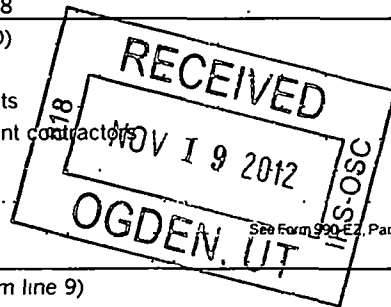




STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

Houston Raiders had 4 teams participate in the 2011 summer programs. Two teams participated as 16U teams and two additional teams participated as 18U teams. Raiders 18U White Team compiled a 28-11 summer record. All teams participated in the Premier program. Premier is a national program with national championship tournaments all over the country. Premier represents the highest level of competition available at the high school level. All 2011 graduates that participated in the Raider's program were afforded an opportunity to play baseball at the collegiate level. The Raiders had 5 former and current players taken in the 2011 June Major League Baseball draft.

The Raiders had over 100 players participate in the 2011 Summer Program. Over 20 of these players were from low income families. Raiders are very proud of the fact that these players were able to participate because of sponsors gifts and fund raising by the Houston Raiders Staff. We look forward to the 2012 season. We would like to offer roster spots to more low income families. We look for our sponsor base to increase. Playing baseball at the club level has evolved into a very costly endeavor. We feel it is important to offer low income kids the opportunity to participate at this high level. Raiders teams participated in National Championships all across Texas and the country. Raiders 18U White was the NABF Senior Division - National Runner Up. Championship was held in Youngstown, Ohio.

The Raiders 2013 program is very promising. Again, we plan to field 4 teams at the 16U and 18U levels. Raiders will help many young men, of all social and economic levels, achieve their goal of playing baseball at the college level and beyond. Many will earn college baseball scholarships and get their degrees as a result.
