We operate three preschools which provide a quality, inclusive early education program for children with disabilities along with children without disabilities. We also serve families across the socioeconomic spectrum. 25% of our children have a disability or are considered at high risk. 35% of our families receive tuition subsidies. In 2011, we served 260 children and their families. In addition to our year-round program, we have a summer enrichment program for elementary school-aged children.
