Emergency Shelter and Supportive Services Family Abuse Center provides a 24-hour crisis line and 55 bed emergency shelter for victims fleeing domestic violence. Services include residential case management, individual and group counseling, legal advocacy, help with transportation and medications, community education, and various other supportive services. Family Abuse Center served over 515 victims in the emergency shelter and 1,172 victims on the 24-hour crisis line. Family Abuse Center serves McLennan, Bosque, Falls, Navarro, Hill, Freestone, and Limestone counties in Texas.

Transitional Housing Family Abuse Center provides a 12 month transitional housing program for 46 families fleeing domestic violence. Program participants are provided with various supportive services including job skills training, individual and group counseling, financial mentoring and computer classes.
