Gallery of Trees programming was changed to a Silent Auction format in 2011. Holiday trees were decorated and donated for auction by local businesses and artisans. There was no fee charged to those decorating trees nor for those attending the event.

Fundraising for the Lincoln Center remodel and renovations continued in 2011. The Lincoln Center re-opened Aug. 2011. Direct payments for furniture, audio system were made from

the Support league checking account. Periodic checks were issued, as requested by the Lincoln Center, to the Center's general fund to cover costs. Fundraising activities have slowed. Remaining funds now in a special account will be transferred to the Lincoln Center upon request.

There were several small grants received by the Lincoln Center Support league to assist in programs at the Lincoln Center. The grants supported a portion of the publicity and reception held in conjunction with the re-opening. Another grant helped offset costs of the local Studio Tour of local artists.

All financial records/reports are available at any time upon request. A final year-end report is presented to all members annually.

Note: Fundraising for remodel/renovation items continues in 2012 for items not covered originally. All funds continue to be deposited in a special account. Funds will either be transferred to the general fund or used to directly cover items requested by the Lincoln Center staff.
