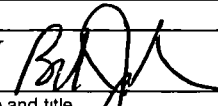
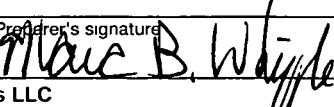

Regarding Part VI, Lines 8 and 11: BAE Systems, Inc. is the sponsor of the trust and the underlying benefit plan. Personnel in the finance department of BAE Systems, Inc. are responsible for maintaining financial records with respect to the trust and underlying benefit plan.

The completed Form 990 was submitted to the BAE Systems, Inc. finance department for review prior to filing with the Internal Revenue Service. There is not technically a "governing body" for the trust. The BAE Systems Administrative Committee (the "Committee") is the plan administrator and named fiduciary for the underlying benefit plan. In this capacity, the Committee has primary oversight responsibility for the funding and operations of the trust. The Committee generally meets at least once every calendar quarter.

Regarding Part VI, Line 15: As a trust, the organization does not have any employees, and thus does not have or need a compensation policy for officers or key employees.

Regarding Part VI, Line 19: The organization's governing documents and financial statements are available for review upon request.

Regarding Part X, Line 6: As the underlying benefit plan uses the modified cash basis of accounting, which recognizes contributions when paid/received, rather than as earned, the financial records of the trust do not record contribution receivables. Participant contributions to fund benefits pursuant to the underlying benefit plan are forwarded to the trust within the time periods required by federal law.

Regarding Part XII, Line 1: The modified cash basis of accounting is the accounting method used to maintain trust records and thus to prepare the Form 990. Under this method, investment assets are reported at fair value; net realized and unrealized appreciation in the fair value of investments is recognized; contributions and investment income are recognized when received rather than as earned; and claims, insurance premiums, and administrative expenses are recognized when paid rather than as incurred.

Regarding Part XII, Line 2: The trust is one of two trusts that funds benefits under an ERISA-governed health and welfare benefit plan, known as the BAE Systems Funded Welfare Benefit Plan (the "Plan"). The Plan's financial statements are audited by an independent accounting firm each year. As the trust's assets comprise a portion of the Plan's assets, by necessity the trust's financial statements are reviewed by the Plan's independent accounting firm. Thus, "Yes" was deemed the correct response to Part XII, Line 2a of the Form 990, but "No" was deemed the correct response to Line 2b, as the audit by the independent accounting firm was not specific to the trust, but

rather related to the Plan. Because there was not a specific audit of the trust's assets, "Consolidated basis" was deemed the best response to Part XII, Line 2d. Thus, "Yes" was answered in line 2c of Part XII.
