Our Purpose: Why We Exist

Founded in 1995, Legacy Family Ministries' (LFM) mission is to pass on God's principles from one generation to the next:

- By *deepening the roots of individuals* with God's truth through mentoring, teaching, speaking, and writing.
- By *developing the foundation of pre-engaged and engaged couples* to grow in Christ and make family a priority through curriculum instruction on relationships, mate selection, and marriage preparation.
- By *encouraging busy families* to focus on what is most important -- God and each other -- through church/community education, retreats, and parent forums.

Our Core Values: What We Believe

Throughout Scriptures the idea of passing on a Biblical legacy is consistent. A society is influenced by the truth of God being taught to the next generation. At LFM these core values guide our ministry model:

1. Passing on God's Principles
2. Building the Foundation - Preventive Education
3. Wholeness/Completeness
4. Deepening the Roots
5. Relationships
6. Mediated Learning - The role of the Holy Spirit
7. Family Interaction

To that end, the program services are broken into three fundamental areas: individuals, couples, and families.

Our services: What we accomplished in 2011

The ministry to individuals in 2011 focused primarily on high school students, college students, and young adults. Carla Weathersbee and Darrell Janecka met with approximately 25 individuals in informal settings for bible study, mentorship, and support. They utilize our resource *Before Forever: How do you know that you know* for seriously dating couples as needed. Vertical, a weekly evangelical and discipleship event targeting college students, continued to meet on or near the Baylor campus; average attendance was about 400 students per event.

The ministry to couples in 2011 was primarily comprised of premarital education classes. This *Countdown* class is based on the principle that it takes three for the two to become one. The class is designed to challenge engaged couples to develop their upcoming marital relationships on a foundation of biblical principles. Several local Waco area classes meet once a week for six weeks at a local home, then end with a weekend retreat at Summers Mill in Salado, TX. The total 2011 class enrollment was 70 individuals (Spring enrollment of 28 couples; Fall enrollment of 7 couples). The classes were taught by Byron and Carla Weathersbee, Darrell and Cindy Janecka, Ted and Gloria Lewis, Brandon and Elizabeth Oates, Benjie and Kimberly Polnick, and Josh and Shannon Morrison.

The *Countdown* syllabus was compressed and provided as a *Weekender* for 72 individuals at Summers Mill (Spring enrollment of 14 couples; Summer enrollment of 13 couples; Fall enrollment of 9 couples). The Weekenders were led by the Weathersbees, Janeckas, and Oates. The Weathersbees also covered the same material with 4 individuals in one-on-one sessions throughout the year.

An additional 81 individuals completed the *Countdown* course as led by LFM trained leaders in Benton, AR; Bryan/College Station, TX; Denton, TX; Lewisville, TX; Longview, TX; Marble Falls, TX; New Braunfels, TX; Seattle, WA; Tyler, TX; Tulsa, OK; and Waco, TX. A total of 112 couples completed LFM's pre-marital education course in 2011.

The Weathersbees hosted a ReUnion retreat for 33 individuals at Summers Mill in December. Byron also officiated 8 weddings, and the various Countdown leaders attended numerous weddings as well.

The ministry to families in 2011 consisted of informal encouragement of our Countdown alumni and other families.
