Operation of a Christian retreat center that hosted and programmed ecumenical
Christian retreats for churches and individuals from various Christian
denominations. In 2011, 40 retreats were held with over 1,840 guests attending.
Nationally known speakers and resource people from across the country were brought
in to help ensure the excellence of these retreats. Financial assistance of \$15,351
allowed individuals and couples in need attend retreats. Financial assistance
from Laity Lodge Speakers' Fund covered 58% of speaker honorariums.

Grants to support affiliated organizations in furtherance of mutual visions around the renewal
transformation of daily life. Grants to Laity Lodge Foundation allowed 122 youth ages 7-16 to attend
a one-week or two-week camp session at a discount or free of charge based on financial need; supported a mission
trip to Jacob's Well in Limbe, Haiti, to assist with a four-day camp for 200 Haitian children; assisted with
construction projects for Jacob's Well; scholarships for 319 individuals to attend a weekend family retreat
through relationships with area nonprofits that provide quality human service programs for disenfranchised families.
Grants to the H. E. Butt Foundation Free Camp Program help with the operation of facilities used by over 250 nonprofits,
representing over 20,000 people, at no charge--especially targeting disadvantaged youth in Texas communities;
construction grants are helping to build a campsite conducive to housing families for retreats thru the
Free Camp Program and the Laity Lodge Family Camp Program.

Promotion of lay renewal as a therapeutic force in the church and in society
through books and publications. Over 4,700 pastors from across the country received

no charge.

In addition, to ensure the Foundation operates in a manner consistent with charitable purposes and does not engage in activities that could jeopardize its tax-exempt status, periodic reviews are conducted. The periodic reviews shall, at a minimum, include the following subjects:

1. Whether compensation arrangements and benefits are reasonable, based on competent survey information, and an arm's length transaction.
2. Whether partnerships, joint ventures, and arrangements with management organizations conform to the Foundation's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes, and do not result in inurement, impermissible private benefit or in an excess benefit transaction.
3. The Foundation will periodically review the policy as a whole and discuss its provisions with all employees who have any responsibility for purchasing or expenditure of funds.

The Executive Vice President and Senior Vice President are paid salaries by a related organization. Compensation is reviewed annually by the Controller/Director of Human Resources, the Executive Vice President, and the Senior Vice President.
