



held in New Orleans. TCE Fund also re-surveyed 198 city websites and staff to, finding that little has changed and most

municipalities are still not educating their residents about the new law and manufacturer-based recycling programs. TCE Fund was

awarded a grant from the Meadows Foundation to raise awareness among residents and local governments about the 2007

legislation and is currently involved in grassroots outreach efforts.

TCE Fund assisted in the research and release of an Electronics Recycling Report Card to assess computer, television, printer and

game console makers based on their recycling and sustainability performance.

TCE Fund continued to participate in an international stakeholder process to develop standards for environmentally preferable

Imaging Equipment (printers and copiers) and TVs. The Environmentally Preferable Electronics Assessment Tool (EPEAT)

standards will be used by consumers and institutional purchasers, such as the U.S. federal government, to select greener products.
