Children who receive high quality childcare are more likely to develop better thinking skills, better language skills and are more likely to develop positive social skills than are children who do not receive high quality care. How adults engage and respond to an infant determine the child's ability to learn, relate to people, and manage his or her emotions. During the first few years of life, the human brain is specifically designed to benefit from positive experiences and teaching, while adverse experiences can have profound, negative effects on children's behavior and learning. The benefits that arise from high quality childcare remain with children into young adulthood. We advocate for the needs of children and support the professional growth of early childhood teachers.
