The senior managers propose the entire cost of staff salaries in the annual budget. Once the budget is approved, the senior managers determine the specific salaries for the rest of the staff. Those salaries are determined in December and effective January 1. In July, the consultant is brought in to determine any adjustments for the senior managers.
