Brother to Brother program is an evidence based HIV prevention program for African American men who have sex with men. The BTB program is listed is a group level intervention designed reduce the number of African American MSMs contracting HIV. The intervention consists of 3 three- hour sessions and has been proven to be effective by the Centers for Disease Control. Seventy-seven individuals successfully graduated from the BTB program in 2011. In addition, hundreds of outreach and educational contacts were made in the African American MSM community.

4b (Code _____) (Expenses \$ 115,193 including grants of \$ 0) (Revenue \$ 0)
The Popular Opinion Leader program is an evidence-based HIV prevention program for Caucasian men who have sex with men. The POL program is a community based program designed to reduce the number of MSMs who contract HIV by increasing the use of condoms. The program consists of two 3-hour sessions. Graduates of the POL program are then tasked with conducting 14 risk reduction conversations with at-risk members of their social and sexual networks. The POL program has been proven to be effective by the Centers for Disease Control. A total of 851 contacts were made with Caucasian MSMs, 65 individuals graduated from the program and 521 risk reduction conversations were tracked.
