THE DISASTER RESPONSE PROGRAM: benefited communities where weather and other humanitarian disasters altered the lifestyles of citizens in 2011. We collected clothes, blankets, can food, arranged medical support, emotional counseling, water, transportation and overall relief for victims and their communities. We mobilized volunteers to help with the clean up, provide warm food for victims and their communities. We partnered with other humanitarian agencies to provide needed services and support in Joplin Missouri, after the maasive hurricane disaster, in Eagar Arizona for the flow fire swept through the place, Hurricane Irene in Coastal North Carolina and Mid Atlantic Coast, Mississippi River flooding in Upper Midwest / Minot North Dakota, drought in Texas, Oklahoma, Louisiana, New Mexico, and Arizona, Tornadoes in Alabama, Southeast and Midwestern states, including the Ohio valley. The Ground hog day blizzard in the Midwest. Our job continued in East Africa where drought and famine claimed over 30,000 lives in Somalia, Kenya and Ethiopia. In Thailand, we provided relief to hundreds of families after the Thailand flooding, The Queensland Australia flooding, the Columbian flooding and after the Tropical Storm Washi in southern Philippines.

THE EMERGENCY HEALTH PROJECT is a worldwide project aimed at combating children mortality in Third world countries. The project is funded and spearheaded with resources from the European Union health grants for developing nations. In the phase 2 of the project, resources are directed toward aggressive anti-Malaria prevention, HIV /Aids containment, measles immunization, prenatal treatment, general health counseling and increased available rural clinic centers in third world centers. The project recruited and is training over 7500 medical professionals and technicians. The program distributed another 7 units of our Mobile Clinics and more than 250,000 tents in over 75 countries. the project distributed medicines and medical supplies in over 100 countries during the program year. It also trained 3800 new volunteers across Africa, central America and Asia respectively.

THE INTERNATIONAL HABITAT PROJECT: This project started in 2010 with grants from EU, participating African nations, and grants from private Foundations. The project major goal is to provide low accommodation for families, the homeless, Veterans from civil wars in Africa and Asia who are transiting into the civilian life by giving them accommodation, training, and readiness to be productive citizens.

The International Habitat Project replicates The Hope Habitat Project in the United States of America - an experimental transient project we started in 2010 in 7 States. The program benefits the homeless and the Veterans who are transiting into civilian life with transient accommodation, training, and readiness to be productive citizens. The all-around program takes 6-9 months for its participants during which time they are exposed to job interviews, guide to start their own small businesses, and detox program for those who have drug and alcohol problems. We help graduates with initial living support - furnitures, mobile homes, utility payments and basic living necessities.
