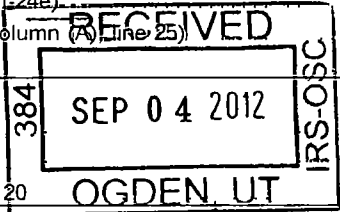

During the year, the 2000 Roses Foundation continued to work the food pantry and clothes closet to assist families in the community with food, fresh produce, toiletries and clothing.

During the year the Directors of the organization continued their emphasis on improving rehabilitation programs being offered to women who are being released from prison and treatment centers.

During this year, the organization continued it's alliance with the Delancey Street Foundation of San Francisco, California. This relationship made additional training resources and support services available to the organization. The Delancey Street Foundation closley monitors the organization's activities in Dallas.
