The primary program service offered by MANNA Worldwide is the operation of nutrition centers and orphanages for indigent children around the world. The number of centers held steady at 129, including 105 overseas outreach centers, 15 orphanages, and 9 U.S. based nutritional outreach initiatives. The feeding programs of MANNA Worldwide are located in approximately 40 different countries and feed over 8,000 children in these locations. The long term goal of these programs is to continue to provide nutritious food, quality education, and to significantly impact children in an effort to help break the cycle of poverty and cultivate thriving communities.

4b (Code:) (Expenses \$ **1,161,614** including grants of \$) (Revenue \$)
MANNA Worldwide provides the opportunity for several hundred people to visit the nutrition centers and orphanages annually. In 2011, MANNA Worldwide facilitated 59 trips to various regions of the world where the volunteers were able to experience firsthand the impact of the programs as they visit the nutrition centers and see the difference made in the lives of the children and their families who participate in MANNA program services.

MANNA Worldwide has a team of self-funded directors who travel across the country to present the mission of the organization. These directors regularly make presentations in churches, civic clubs, business luncheons, and conferences to promote MANNA Worldwide and its programs and the benefits of personal and corporate involvement. Other purposes of the MANNA directors' travel is to visit MANNA Worldwide nutrition centers, oversee the usage of funds for program services, develop new projects, and maintain relationships with MANNA Worldwide contributors.
