COMMUNITIES TAKE ROOT (\$95,162)This program involves donating and planting fruit tree orchards for communities that have shown a strong commitment to an orchard project FTPF also provides onsite fruit tree care workshops and ongoing consultations to orchard stewards to ensure that the trees thrive In 2011, FTPF created 24 large orchards across the country at facilities including food bank farms, public parks, and community centers for the disadvantaged More than 900 fruit trees and shrubs were planted with about 1250 volunteers

FRUIT TREE 101 PROGRAM (\$48,140) FTPF's "Fruit Tree 101" program donates and plants fruit tree orchards at public schools of all levels, across the country, to provide generations of students and teachers with healthy nutrition options and environmental education opportunities Students and teachers participate in plantings with FTPF administering a curriculum focused on sustainability and healthy nutrition As a result, many enthusiastic children become activated to take positive action for their communities Many schools use the orchards as outdoor classrooms to teach concepts in botany and ecology The orchards also provide a source of organic produce for improved nutrition in school lunch programs In 2011, FTPF created large schoolyard orchards for 20 public schools across the country and held environmental lessons for thousands of students, with more than 950 volunteers participating
