HAD FOUR SOCIAL EVENTS IN 2011. THE MAIN FUND RAISING EVENT WAS A CONCERT/DINNER IN LODI. TWO GOLF/DINNER EVENTS IN TRUCKEE WERE ALSO HELD. THE FOURTH EVENT WAS A RESTAURANT TAKEOVER IN STOCKTON. AS A RESULT OF THESE EVENTS AND GENERAL CONTRIBUTIONS MADE TO THE FOUNDATION, THE FOUNDATION WAS ABLE TO GIVE \$53,237 TO LOCAL SOCIAL WELFARE ORGANIZATIONS, \$50,000 TO LOCAL CANCER RESEARCH, \$28,000 TO SUPPORT A LOCAL HOSPITAL, AND \$127,775 TO HELP THOSE SUFFERING CATASTROPHIC INJURIES, INCLUDING LOCAL PATIENTS. THE FOUNDATION WAS ALSO ABLE TO GIVE AN ESPECIALLY EQUIPED VAN WITH A VALUE OF \$10,200 TO A LOCAL YOUNG MAN INJURED IN AN ACCIDENT. IN TOTAL, THE FOUNDATION WAS ABLE TO PROVIDE BENEFITS TO THOUSANDS.
