Housing Services - HUD housing assistance program provides rental assistance to help low-income families afford decent, safe, and sanitary rental housing. Approximately 4,090 people served.

Emergency Services - Emergency services consists of three programs: LIHEAP-CEAP, West Texas Utility Neighbor to Neighbor, and Atmos Share the Warmth. LIHEAP-CEAP are federal dollars offered to qualified individuals (at or below 125% of the poverty level) to assist them with energy bills. This could be gas, electric, propane, etc. They apply once a year and must meet a variety of other standards. West Texas Utility and Atmos are utility gas companies. They collect donations from their customers and in turn create rules under which their customers can ask for assistance. We receive the funds from them and offer to qualified individuals who are customers of the company. Approximately 30,835 people served.

Weatherization Services - Weatherization provides services to help low-income people improve residential energy efficiency. Approximately 978 people served.
