EDUCATION, AWARENESS, ADVOCACY & SUPPORT: Hosted 9th annual education and awareness event. Public education videos were enhanced and public service announcements made, increasing the visibility of the spectrum of eosinophil associated disease among the public. The eLearning center was completed and launched, complete with updated educational materials on a variety of eosinophil associated diseases, FAQ's, videos and more. The new Children's Book "Gus and Phil" was completed, printed and distributed as a learning tool for children, parents and educators. A one-page summary on the 2011 Updated Consensus recommendations for the diagnosis and management for Eosinophilic Esophagitis was being developed and will be completed and distributed in 2012.

RESEARCH: APFED distributed several research grants in 2011 totaling over \$ 260,000.
