2011 achievements

The SFI program's goals are founded on integrity, conservation, community and market outreach, and its success relies on the involvement and support of more than 2500 individuals and organizations. The result is increased acceptance of forest certification and the SFI program among stakeholders and throughout the supply chain. This is important at a time when less than 10 percent of the world's forests are certified to a credible program like SFI that delivers benefits to local communities and to the environment. Our forest certification standard is based on principles that promote sustainable forest management, including measures to protect water quality, biodiversity, wildlife habitat, species at risk, and forests with exceptional conservation value. Some of the accomplishments in 2011 include:

- SFI Conservation and Community Partnerships Grant Program:
 - The program, launched in 2010, funded six new projects in 2011 led by Dalhousie University, Ducks Unlimited Canada, Nature Conservancy Canada, Audubon New York, The Nature Trust of British Columbia, and a partnership involving the Land Trust of Tennessee, the North Carolina Land Trust and Wildlands Network.
 - SFI Inc. introduced a program extension to support smaller community-based projects, and awarded nine grants to support forest education activities and green building for low-income families.
 - SFI invested \$464,200 in 2011, for a commitment to the grant program to date of \$1.14 million. The total value with partner commitments is expected to reach \$4.2 million.
 - The 24 projects supported in 2010 and 2011 brought together about 125 partner organizations to advance important conservation and community work.
 - Wide-ranging project results include information to improve management of forest habitats for endangered species, research and outreach so landowners can improve wildlife habitat, and planting of the first blight-resistant American chestnut trees.
- In partnership with our SFI Implementation Committees, we continued to work with local Habitat for Humanity chapters to build homes for hard-working, low-income people using materials from sustainable resources. In 2011, this included a two-family home in Fredericton, New Brunswick, and support through our grant program for the National Housing Endowment to certify Habitat for Humanity Homes to the ANSI/ICC 700-2008 National Green Building Standard.
- SFI Inc. sponsored the Fourth Potomac Forum on Illegal Logging and Associated Trade in Washington, hosted by Forest Trends. Other sponsors included the World Bank, the U.S. Agency for International Development, (USAID), PROFOR, the U.S. Forest Service and Forest Legality Alliance.
- The SFI Board of Directors approved changes to the SFI on-product labels to provide a tighter link between the terms on the labels and definitions found in the SFI 2010-2014 Standard.
- The SFI forest standard once again met the rigorous third-party assessment of the Programme for the Endorsement of Forest Certification (PEFC).
- Three new certifications in 2011 (Yakama Nation, Miitigoog General Partner Inc. and Stuwix Resources Joint Venture) brought the amount of land held by or managed for Aboriginal communities and certified to the SFI Standard to more than five million acres/two million hectares.
- 196 million acres/73 million hectares of forestland across North America were certified to the SFI Standard at the end of 2011 – eight percent more than at the end of 2010. There were 1,026 chain-of-custody certifications – seven percent more than at the end of 2010.
- In Maine, 790,000 acres/320,000 hectares of additional forest lands were certified to the SFI Standard through an innovative pilot project involving Time Inc., Hearst Enterprises, National

Geographic Society, Verso Paper Corp. and Sappi Fine Paper North America. It was an extension of an earlier project, bringing the total of additional certified lands to 1.4 million acres/570,000 hectares.

- George H. Finney, President of Bird Studies Canada and John B. Crowe, Chairman and Chief Executive Officer of Buckeye Technologies Inc. of Memphis, TN, were elected to the SFI independent Board of Directors. Four new members were elected to the SFI External Review Panel.
- We launched a new on-line SFI Certification Database at www.sfi.org/forest-products/index.php to help buyers find wood or paper products from responsible sources, and improve our program's administrative efficiency.
- SFI Inc. provided information to help bioenergy companies using forest products as feedstock understand how certification can help them meet their environmental goals, and is involved in a pilot project with The Nature Conservancy to help U.S. bioenergy companies support responsible forest management through their procurement of woody biomass.
- The list of organizations that recognize SFI on-product labels grew in 2010, and included the U.S. Department of Agriculture, the U.S. Department of Education, the International Green Construction Code (IgCC) and Underwriters Laboratory (UL) 880 standard.
- **Responsible fiber sourcing:** The SFI program's fiber sourcing requirements continued to improve conservation efforts on uncertified lands in North America. In addition to the raw material coming directly from certified forests, the remaining wood fiber used by SFI program participants met the fiber sourcing requirements of the SFI Standard. Responsible fiber sourcing promotes, among other things, conservation of biological diversity and Forests of Exceptional Conservation Value, use of best management practices to protect water quality and reforestation on forestlands that are not certified. SFI and our program participants are involved in or had recently completed numerous conservative-based projects and educational activities, most involving collaboration with conservation organizations, state or provincial agencies, academic institutions, family forest owners and other forest product companies. Conservation groups involved in these partnerships included The Nature Conservancy, Society of American Foresters, Open Space Institute, Forest Footprint Disclosure, Ducks Unlimited Canada, Bird Studies Canada, Partners in Flight, The Longleaf Alliance and the Ruffed Grouse Society.
