Business start-up training and technical assistance to low-income aspiring entrepreneurs looking to start or grow a business in the construction, cleaning, childcare, recycling, or food industries. In 2011 GMEN, through its grantees, implemented 92 orientation sessions, conducted 233 client assessments, trained and provided technical assistance to 122 aspiring businesses, and supported the start-up or growth of 40 businesses.

4b (Code:) (Expenses \$ 36,822 including grants of \$) (Revenue \$)
The GMEN microLEAD Academy™ (MLA) was a suite of capacity building services to facilitate expanding the scale, service offerings and impact of microenterprise development organizations (MDO's) and microenterprise development programs inside other organizations. This tool was an opportunity to measure a program's level of meeting industry standards of performance. There are 68 criteria divided into three (3) categories of standards: organizational development, program design, and impact analysis. This included research and development of resources for MDO earned income strategies and data collection vehicles.

Capacity building training to microenterprise development organizations at the GMEN annual summit on entrepreneurship. The annual summit focus was on providing best practices in the areas of organizational development, program design, and impact analysis. The 2011 summit had great attendance and more than 30 presenters from across the country sharing their best practice experiences.
