THE THYROID, HEAD AND NECK RESEARCH CENTER (THNRC) HAS BEEN ESTABLISHED TO CARRY OUT THYROID, HEAD AND NECK RESEARCH. THE PROGRAM EMPLOYS A SENIOR LEVEL SPEECH AND SWALLOWING THERAPIST WHO HEADS UP THE RESEARCH CONDUCTED. THE RESEARCH IS DESIGNED TO POOL PATIENT DATA WITH OTHER RESEARCH CENTERS THROUGHOUT THE WORLD IN ORDER TO ACHIEVE STATISTICAL SIGNIFICANCE. THE GOAL IS TO ACQUIRE CRITICAL INFORMATION REGARDING THE EFFECTS OF CANCER THERAPY SO TREATMENTS CAN BE TAILORED TO THE INDIVIDUAL PATIENT, AND THEIR QUALITY OF LIFE CAN BE IMPROVED. AREAS WHICH ARE BEING STUDIED INCLUDE FUNCTIONAL ASSESSMENT OF VOICE, SPEECH, TONGUE FUNCTION, AND SWALLOWING AND QUALITY OF LIFE. CLINICAL

THE THANC FOUNDATION SUPPORTS SCIENTIFIC CANCER RESEARCH BOTH WITHIN THE ORGANIZATION AND OUTSIDE OF THE FOUNDATION. THANC FUNDS HEAD AND NECK AND THYROID CANCER RESEARCHERS/INVESTIGATORS AT A VARIETY OF EDUCATIONAL AND MEDICAL INSTITUTIONS, AT A SENIOR INVESTIGATOR LEVEL AND AT THE JUNIOR INVESTIGATOR LEVEL. FURTHER, THANC HAS PROVIDED FUNDS TO THE AMERICAN THYROID ASSOCIATION (ATA) FOR THEIR USE IN FUNDING NOVEL RESEARCH STUDIES SEEKING A BETTER UNDERSTANDING OF, OR A CURE FOR THIS RAPIDLY INCREASING CANCER.
