Staff development included trainings as part of staff meetings, and participation by staff in trainings offered by the League of Conservation Voters, Montana Non-Profit Association and fundraising trainer Andy Robinson. MCV staff carried out their professional development plans including training on civic engagement, environmental policy and fundraising skills. Total expenses: \$33,053
