Community Organizing and Outreach. This program involved MCVEF's coordination of the work of the Billings Conservation Roundtable and the Missoula Conservation Roundtable, which convened network gatherings held 9 - 10 times per year as a public service to conservation and environmental groups in those communities. Attendance at the Roundtables ranged from a low of 7 to a higher of 29, with an average attendance of 13 in Billings and 15 in Missoula. MCVEF's outreach program also included participation in the Great Falls Conservation Roundtable, and the Flathead Conservation Roundtable. MCVEF's outreach program in 2011 included the formation of the Montana Voices non-partisan collaborative, bringing together groups that work on civic engagement and progressive public policy. This table is now standing on its own with a director and shared program plan. Total expense \$41,815

Leadership and Staff Development accomplishments included the launching of a new program "Conservation Leadership Project", which establishes a new "Ladder of Engagement" that places MCVEF's volunteers and program participants on various levels of involvement. The Project, part of a 4-group cohort, has resulted in an increase in involvement and engagement in MCVEF's activities over baseline levels established at the beginning of 2011 by 27 percent for all people on MCVEF's pyramid (more or less depending on the level where the individuals started at). MCVEF convened two leadership programs including a retreat in Arlee in fall, 2011. Staff development expenses are included in this total. Total expense: \$29,370

MCVEF seeks a more informed, educated and empowered conservation and environmental community in Montana, who takes part in this state's democratic process.

Conservation Policy Program: MCVEF coordinated public education and state legislative services assistance to voters during and after the Montana 2011 legislature, contracted with Montana Conservation Voters to ensure a robust presence in the state legislature and in post-legislative meetings, advocating policies affecting clean air and water, wildlife, forests, open space and public involvement in permitting. MCVEF provided a grant to Montana Conservation Voters of \$50,000 for this work, which also included coordination of "The Conservation Working Group", a table of allied groups that convened regularly in 2011 to discuss proposed state environmental policy.

MCVEF provided staff support to groups participating in the interim legislative energy committee, which is convened to shape a state energy policy. MCVEF also coordinated monthly calls about the Montana State Board of Land Commissioner's meetings, and organized testimony, media and materials to regarding the Land Board's action on the Habitat Conservation Plan.

MCVEF worked in partnership with the national League of Conservation Voters Education Fund to educate citizens, local and statewide decision makers on the impacts of climate change and clean air policies on public health, fish and wildlife and a clean energy future. A good share of this work included coordination of a statewide coalition, the Clean Air Act Protection Campaign, handled by MCVEF's consultant.

MCVEF took on a new campaign in 2011, working with the national League of Conservation Voters Education Fund and the Safe Chemicals Coalition to educate the public and local decision makers about the re-authorization of the federal Toxics Substances and Control Act (TSCA) and proposals to ensure greater safety in household products and chemicals. The campaign included broad public outreach with constituent groups, letters to the editor, guest commentaries, and public forums.

MCVEF also worked on clean energy and environmentally sound transportation and trails policy in Bozeman, Billings, Whitefish and Missoula with the respective city decision makers. New local policies, ranging from responsible city planning around Whitefish Lake in Whitefish to "Complete Streets" in Billings to improved energy conservation policies in Bozeman are the result.

MCVEF List Enhancement and Voter Rights: In the first 4 months of 2011, MCVEF organized phone bank lists and mailing lists a total of 49 times to ensure the members of groups were getting clear information about actions in the legislature, and bills going to the Governor for signature. This was done through the MCVEF List Project. MCVEF also now serves as the data base coordinator of the Montana Voices table, and in 2011, began upgrading its internal data base to most effectively

coordinate with other state groups. MCVEF also provided training and technical support to other allied groups in using the list of registered voters and the MCVEF List Project. Related to this, MCVEF's voter rights work in 2011 included a non-partisan mailing to citizens who were listed on the state's "inactive voter list" who were also members of the MCVEF data base, to encourage them to re-activate their voter registration status. MCVEF also participated in a meeting convened by the Montana Secretary of State to discuss ways to educate voters about new polling place consolidation challenges. Total expense \$27,607
