THE ORGANIZATION GIVES EQUESTRIANS OF ALL AGES THE OPPORTUNITY TO COMPETE IN THE WESTERN UNITED STATES IN COMPETITIONS THAT ARE SANCTIONED BY A NATIONAL PARENT ORGANIZATION, THE UNITED STATES EVENTING ASSOCIATION HEADQUARTERED IN LEESBURG, VIRGINIA AND THE INTERNATIONAL SANCTIONING ORGANIZATION, FEDERATION EQUESTRE INTERNATIONALE, SWITZERLAND. THE MAIN EVENT CALLED THE EVENT AT REBECCA FARM IS HELD IN JULY OF EACH YEAR. THE COMPETITOR PERFORMS A COMBINATION OF DRESSAGE, CROSS COUNTRY AND STADIUM JUMPING OVER A 3 DAY PERIOD. THERE WERE 14 DIVISIONS OFFERED FROM NOVICE TO ADVANCED. THE EVENT WAS A WORLD CUP QUALIFIER FOR THE TOP LEVELS COMPETING. IT IS PART OF A CIRCUIT OF SIMILAR EVENTS THAT TAKE PLACE ACROSS THE U.S. AND THE WORLD. THE EVENT SERVES AS A SPRINGBOARD FOR RIDERS TO ADVANCE TO MAJOR NATIONAL AND INTERNATIONAL EQUESTRIAN COMPETITIONS, INCLUDING THE OLYMPICS. SEVERAL CLINICS AND SHOW JUMPING COMPETITIONS ARE ALSO OFFERED THROUGHOUT THE SEASON THAT ENABLE REGIONAL EQUESTRIANS TO TAKE LESSONS FROM TOP NATIONAL AND INTERNATIONAL RIDERS AND COMPETE IN SHOW JUMPING. EACH CLINIC BENEFITS FROM 20-30 STUDENTS, SHOW JUMPING EVENTS AVERAGE 80 COMPETITORS. THE PRIMARY SERVICE ACCOMPLISHMENT IS STAGING THE EVENT AT REBECCA FARM ANNUALLY FOR APPROXIMATELY 500 COMPETITORS. OVER SEVERAL MONTHS PRIOR TO THE EVENT, THE COURSE IS PREPARED TO APPROPRIATE STANDARDS, TEMPORARY STABLES ARE INSTALLED AND QUALIFIED OFFICIALS ARE HIRED. VOLUNTEERS ALSO HELP IN STAGING THE EVENT. PLANNED FUND RAISING TAKES PLACE TO SOLICIT SPONSORS TO OFFSET THE COSTS NOT COVERED BY ENTRY FEES SUCH AS PROGRAM PRODUCTION, PRIZE EXPENSE, ORGANIZATION FEES, SECURITY, TOILET RENTAL AND GARBAGE REMOVAL, ETC. APPROXIMATELY 22,000 SPECTATORS ATTEND THE EVENT AT REBECCA FARM. THE ANNUAL EVENT IS BECOMING VERY POPULAR AND SPECTATOR ATTENDANCE IS EXPECTED TO GROW IN YEARS TO FOLLOW. ADMISSION IS FREE TO SPECTATORS AND HANDICAP ACCESS IS AVAILABLE. A TRADE FAIR OF EQUESTRIAN RELATED PRODUCTS, WHICH ATTRACTS INDEPENDENT VENDORS, ALSO TAKES PLACE DURING THE EVENT. INDEPENDENT FOOD CONCESSIONS ARE PRESENT DURING THE 3 DAYS FOR SPECTATORS ALONG WITH AN EVENING BBQ. THE COMMUNITY ALSO BENEFITS FROM THE RECREATION PROVIDED TO COMPETITORS AND SPECTATORS. THE COMMUNITY BENEFITS FROM AN ECONOMIC STANDPOINT IN THAT THE AVERAGE COMPETITOR FROM OUT OF THE AREA (APPROX. 3/4 OF ENTRANTS) BRINGS 4-5 PEOPLE WITH THEM AND STAY AN AVERAGE OF 5 DAYS.
