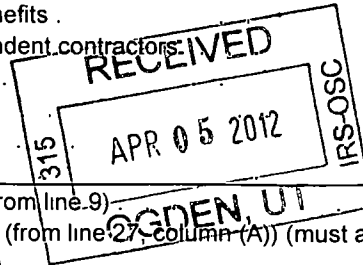

We received a letter of encouragement from Christian Schmidt, Under-Secretary of Defense of Germany. Given favor for distribution of Christian Literature throughout the Armed Forces of Germany.

Made contact with German military officials about distribution of Bibles in the following cities of Mittenwald, Murnau, Bayreuth, Bamberg, Regensburg, Amberg, Chemnitz, Dresden, Bonn, Berlin, Neuberg an der Donau, Wuerzburg, Aschaffenburg, and Cham. Also Bibles were sent to German soldiers in Kosovo and Afghanistan. A total of 10,000 Bibles have been distributed.

Met with German military leaders from a Christian organization called "Cornelius Vereinigung". Shared about the work of "Operation Centurion" at one of their conferences in Koenigswinter, Germany. Also we met with a representative of "Arbeitskreis Soldaten der Deutschen Ev. Allianz". We are working together with these two organizations in reaching German military soldiers for Christ.

We are currently in the process of fund-raising to reprint the German Military Bible, which should be completed by fall 2012.

Made trip to Russia in May 2011 checking on our Operation Centurion team. A total of 1650 Bibles were distributed in the cities of Rostov-na-Donau, Archangelsk, Ulyanovsk, Moscow, Kamishin, Volzhsky, Volgograd, Vyazma, Rostov, Nizhniy Gnutov, Perm, Sverdlovsk Oblast, Lipetsk, Pyatigorsk, Chaltyr, Khabarovsk, Zaokskiy, St. Petersburg, and Minusinsk. Bibles were also distributed in these countries: Ukraine, Belarus, Kazakhstan, and Armenia.

We are also working together with the Nazarene Church of the Northwest District of Russia.

Helped prepare food and teach Bible Studies for a US Servicemen's Prayer Breakfast in Vilseck, Germany at military chapel meeting twice a month.

Also taught Bible Studies for US military wives through Protestant Women of the Chapel. Provided marriage counseling for returning US soldiers from Iraq and to their wives. Also, we have supported US Military Chaplains through participating in Chapel functions and providing counseling for them as well.

Have shared at churches in America and Germany about the ministry of Operation Centurion.
