Statement of Program Service Accomplishments

Mmametlhake Family Care Center (MFCC):

This non-profit education and health care facility continues to broaden its scope in regard to the eradication of HIV and AIDS in the community of Mmametlhake and beyond through education and awareness training, in-clinic treatment and counseling, and home based care. Under the governance of a board of directors, MFCC employs full-time office and administrative staff, three counselors and nine home-based care workers. The center is garnering the attention of local government officials and school administrators who are welcoming the HIV/AIDS awareness seminars put on by the staff of MFCC. The impact of MFCC's work also is gaining world-wide attention as they were awarded a Peace Corps volunteer for the second year in a row in 2011. Currently, plans are underway for the board of MFCC to introduce their successful model to other neighboring communities.

Tabitha Ministries:

Located in Kwa Zulu Natal Province, Tabitha Ministries is involved in hands on, daily care for 60 orphaned and HIV infected children, more than 5,000 children residing in child-headed households, and around 1,200 AIDS patients. The Foundation supports Tabitha home-based care workers and construction projects for additional on-site housing for abandoned children and hospice patients.

Soccer Program:

A soccer team was started by a counselor from Mmametlhake Family Care Center to keep the children of a neighboring village active and HIV-free. The Foundation funded the purchase of uniforms, shoes and equipment for 16 boys to become the first competitive soccer team in the village.
