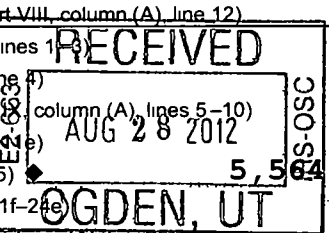

**BYLAWS OF  
The 24 Group, Inc.

(Original bylaws April 2006, revised March 2009)**

**ARTICLE 1 - NAME, PURPOSE**

- Section 1           The name of the organization shall be The 24 Group, Inc.
- Section 2:           The address of the Organization's principal offices is 11214 Echo Ridge Lane, Indianapolis, Indiana 46236.
- Section 3:           The 24 Group Inc is a foundation formed by families who believe that those affected by addiction in adolescents and young adults deserve support and advocacy. Because current resources are inadequate, The 24 Group exists to provide a means for those in need of addiction education and recovery support.

**ARTICLE II - BOARD OF DIRECTORS**

- Section 1:           Board Role, Size, Composition. The Board is responsible for overall policy and direction of the Organization. The responsibility of day-to-day operations should be delegated to the Organization's Executive Committee until such time as a salaried Executive Director is employed by the Organization. The Board shall have up to fifteen and no fewer than ten members. The board receives no compensation other than reasonable expenses.
- Section 2:           Meetings. The Board shall meet at least quarterly, at an agreed upon time and place. The annual meeting of the Board shall occur in April of the calendar year, or at a date approved by the Board.
- Section 3:           Board Elections. Up to fifteen Board members shall be elected. When applicable, the Executive Director of the 24 Group is considered a voting member of the Board of Directors and is so by default.
- Section 4           Governance Committee. A Governance Committee shall be appointed by the Board to slate Board Member nominees and officers to be presented for approval of the current Board, orientation of Board Members, and evaluation of Board Members eligible for reelection.
- Section 5           Terms. All Board members shall serve three-year terms, but are eligible for re-election.
- Section 6:           Quorum. Simple majority of the Board members must be present to establish a quorum. A quorum is required before official business can be transacted or motions made and approved.
- Section 7:           Notice. An official Board meeting requires that each Board member have notice at least two weeks in advance.
- Section 8:           Officers and Duties. There shall be three officers of the Board consisting of a Chair, Vice-Chair/Secretary, and Treasurer. No officer may be related by family to other officers. The officers shall be presented by the Governance Committee and elected by the Board at the Annual meeting of the Board. Their duties are as follows:
- The **Chair** shall convene regularly scheduled Board meetings and preside over official Board business.

The **Vice Chair/Secretary** shall serve in place of the Chair if the Chair is unavailable, and shall be responsible for keeping records of Board actions, including overseeing the taking of minutes at all board meetings, sending out meeting announcements, distributing copies of minutes and the agenda to each Board member, and assuring that corporate records are maintained

The **Treasurer** shall manage the organization's financial transactions, oversee preparation of the annual budget and appropriate IRS filings, and make financial information available to Board members and the public. The Board must approve the budget, and all expenditures must be within the budget. Any major change in the budget must be approved by the Board or the Executive Committee. The fiscal year shall be the calendar year. A Treasurer's report shall be presented at each Board meeting

Section 9: Vacancies. When a vacancy on the Board exists, nominations for new members shall be presented by the Governance Committee two weeks in advance of a Board meeting. These nominations shall be sent out to Board members with the regular Board meeting announcement, to be voted upon at the next Board meeting. Any person elected to fill a vacancy shall serve the unexpired term and until the person's successor is elected and qualified

Section 10: Resignation and Termination. Resignation from the Board must be in writing and received by the Board Chair. A Board member may be removed for failure to comply with Board policy by a two-thirds vote of the remaining directors

Section 11: Special Meetings. Special meetings of the Board shall be called at the request of the Chair or one-third of the Board.

### **ARTICLE III - COMMITTEES**

Section 1: The Board may create committees as needed. There shall be two standing committees – Executive and Governance Committees. The Board Chair appoints all committee chairs. Committee chairs must be members of the Board. Other committee members may be recruited from outside the Board membership.

Section 2: Executive Committee: The three officers serve as the members of the Executive Committee. If applicable, the Executive Committee shall review the performance of the Executive Director. Except for the power to amend the Articles of Incorporation and Bylaws, the Executive Committee shall have all of the powers and authority of the Board of Directors during the intervals between meetings of the said Board, subject to the direction and control of the Board of Directors. The Executive committee serves as a grievance officiator and is responsible for bringing internal policy changes to the full Board for voting purposes. The Executive Committee of the Board will have day-to-day responsibility for the Organization, including carrying out the Organization's goals and Board policy, until such time as the Board determines the need to hire a salaried Executive Director

### **ARTICLE IV - DIRECTOR AND STAFF**

Section 1: Executive Director. The Executive Committee of the Board will have day-to-day responsibility for the Organization, including carrying out the Organization's goals and Board policy, until such time as the Board determines the need to hire a salaried Executive Director. When applicable, the Executive Director will attend all Board meetings, report on the progress of the Organization, answer questions of Board members and carry out the duties described in the position description. The Board can designate other duties as necessary.

- a) When applicable, the Board as a whole is responsible for hiring the Executive Director. In the event that the Executive Director position is vacated, the Executive Committee of the Board is in charge of forming an Executive Search Committee, which committee is responsible for position description, application process, and selection of final candidates. The Executive Committee will conduct the final interviews with candidates recommended by the Search Committee. The final candidate selected by the Executive Committee must then be recommended to the full Board and approved before an official offer is presented. The Board Chair is responsible for presenting final offer to selected candidate.
- b) When applicable, an annual review of the Executive Director will be conducted by the Executive Committee. Compensation will be based on results of the annual review and Finance Committee's recommendation

#### **ARTICLE V - AMENDMENTS**

Section I:

These Bylaws may be amended when necessary by a two-thirds majority of the Board of Directors. Proposed amendments must be submitted to the Board in writing.
